- 4. Pre-bid meeting shall be held at *Tansen Municipality Office*, *Tansen*, *Palpa* at *14:00 hours on* 2076/09/21 (Jan. 6, 2020)
- 5. Sealed or electronic bids must be submitted to the office *Tansen Municipality Office*, *Tansen*, *Palpa* by hand/courier or through PPMO website www.bolpatra.gov.np/egpon or before 12:00 hours on 2076/10/03 (Jan.17, 2020). Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours on 2076/10/03 (Jan.17, 2020) at the office of Tansen Municipality Office, Tansen, Palpa. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of as mentioned Above which shall be valid for 30 days beyond the validity period of the bid (i.e. (2077/02/04) (May17,2020).
- 7. If a bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in *Deposite Account No. 3030303007102 at Rastriya Banijya Bank Branch Office, Tansen Palpa*, and the receipt of the deposited cash amount shall be submitted along with the bid.
