2. Eligible Bidders may obtain further information and inspect the Sealed Quotation Documents at the office of Tansen Municipality Office, Tansen, Palpa, telephone no.075520909.

A complete set of Sealed Quotation documents may be purchased from the office Tansen municipality office, Tansen, palpa by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs. 1000.00 till 24<sup>th</sup> Jestha 2075 during office hours.
4. Sealed bids must be submitted to the office Tansen municipality office, Tansen, Palpa on or before 12:00 hours on 25<sup>th</sup> Jestha 2075. Bids received after this deadline will be rejected.

The Sealed bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours on 25<sup>th</sup> Jestha 2075 at the office of Tansen Municipality Office, Tansen, Palpa. Sealed Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting as given bellow in table which shall be valid for 30 days beyond the validity period of the sealed bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No. 3030303007102 at Rastriya Banijya Bank, Tansen, Palpa and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
7. The Purchaser reserves the right to accept or reject, wholly or partly any or all the Sealed Quotations without assigning any reason, whatsoever.
