Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Pre-bid meeting shall be held at *Tansen Municipality Office, Tansen, Palpa* at **14:00 hours on 2077/08/09 (Nov. 24, 2020)**.
5. Sealed or electronic bids must be submitted to the office *Tansen Municipality Office, Tansen, Palpa* by hand/courier or through PPMO website www.bolpatra.gov.np/egpon or before **12:00 hours on 2077/08/19(Dec.04, 2020)**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 hours on 2077/08/19 (Dec. 04, 2020)** at the office of *Tansen Municipality Office, Tansen, Palpa*. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of *as mentioned Above* which shall be valid for 30 days beyond the validity period of the bid (i.e. (2077/12/23) (April 05,2021).
7. If a bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in *Deposit Account No. 3030100303000004 at Rastriya Banijya Bank Branch Office, Tansen Palpa*, and the receipt of the deposited cash amount shall be submitted along with the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
